## Agreement between User and <https://lynkoid.com>

Welcome to <https://lynkoid.com>. If payment is not received within 30 days of the invoice date, the account may be suspended until payment is made in full. It is your responsibility to ensure that payment is received on time. You may request an extension for payment if necessary, but any such request must be made in writing and approved by Lynkoid prior to the payment due date.

### **Cancellation/Refund Policy**

You may cancel service at any time. Billing will be prorated up to the time of cancellation. Completed service and setup fees are non-refundable.

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted.
